

## **Stark County Ski Club Zoom Meeting February 15, 2022**

**Call to Order:** President Michael Bishop called the meeting to order at 7:05 p.m., allowing people to join via the Zoom platform. He welcomed attendees (18 logged on) and reminded all to be on mute until recognized. Mike Bishop asked for a motion to not review the previous meeting minutes. Fred Scherer made the Motion, which was seconded by Scott Hunsinger.

Mike Bishop called for the following reports:

### **Officer / Chair Reports**

**President Report:** Mike Bishop stated there was no Old Business to review. There is a \$5 cover charge towards the cost of the room and \$3 fee for euchre. Those who miss getting one of the 24-euchre spots or just want to play something else can play other games. BYOB, alcohol allowed. Diane will be sending out information for the July 15-17 Mohican camping trip and she and Gail are also looking at a white-water rafting trip in the fall. Gail has been gathering information on the new comedy club in Massillon for a potential social.
