Hey fellow Skiers and Riders,

We welcome November's colder weather in hopes of bringing us an early snow and start of the ski season. As of writing this, there is snow in our forecast (flurries) and we'll take what we can get. Coming up in December we are planning on participating with Elves and More of Northeast Ohio, a charity that gives out new bicycles to entire neighborhoods with a high saturation of underprivileged children. We will be participating in the Bike build; if you would like to join us please let me know by the 10th of November. It would be best if you had basic bicycle building tools and some mechanical skills. Those who are mechanically challenged but still would like to participate, fear not there are also non-mechanical tasks that need to be performed that you would be a great help with. A binding function test will assure that the binding properly releases when needed.

The Constitutional review board and executive committee has just finished up with our constitutional review, we dotted all of the i's and crossed all the t's, please take the time to review all of the proposed changes to the constitution as placed in this newsletter, we will have physical copies available for review at the November meeting, and be voting on those proposed changes at our December meeting. One of the biggest changes you will see is our changing of our membership renewal date to June 1st, this change will be welcomed by all of our trip leaders as there will be no gray area of who is or is not a member at the time of trip sign-ups. 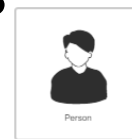

Call to Order

President Jason Stephan called the meeting to order at 7:00 p.m. He welcomed everyone and there were no new members or guests to introduce. Forty-seven (47) individuals were in attendance. Jason called for the following reports:

Officer / Chair Reports

President Report: Jason Stephan gave a constitutional review progress report, please see under Old Business. Jason noted that our best marketing tool is our members and showed the new tabletop banner which will be displayed at socials. It is smaller and more portable than our larger banner. The hope is when people see our group having fun, they'll see the banner and ask questions. Jason mentioned the \$10/\$10/\$10 deal at Snowtrails is a great way to introduce skiing or snowboarding to friends and family. Jason is asking for volunteers to help build bicycles with a non-profit group, Elves and More, who purchase and build bikes for kids. Contact Jason to help, will be approx. 9 am- 1pm, December 14 at warehouse space in the Akron area to be determined.

Vice President Report: Jeri Johnson thanked everyone for the cards and prayers. She reminded us that the Kick-off the Season party will be December 1st at The Barrel Room from 5-9:30pm. The Club will provide chicken and pizza; members are asked to bring a covered dish. Please RSVP to Jeri so they can plan for food. New this year the Barrel Room will be adding a 20% gratuity to your bar bill. Jeri reminded everyone that we are hosting the CMSC November 7th meeting, 7 pm at Mulligan's and you are welcome to attend. If you are interested in a name tag, Jeri is taking orders and they cost \$7.50.

Treasurer Report: Melba Gasque reported on the amount in the club treasury and that she has a credit card reader at the meeting to take membership dues. She noted she still has outstanding vouchers totaling around \$1,000 from our time at Blossom that haven't been turned in. It was decided those will need to be used this year so if you are hanging on to OLD vouchers, please use. It is understandable when trips get cancelled that they haven't been used but at some point the older ones won't be accepted. It was reported that Melba will be out of town for a few months and Donna Brancifort will step in to help the Treasurer duties while she is out.

Secretary Report: Jennifer Stephan reported she had \$145 in the 50/50 raffle and would sell for anyone wanting tickets before the drawing.

Fundraising Report: Donna Brancifort handed out \$3,285 in trip discount vouchers to workers at the meeting which brought this year's total to \$10,728. She will be keep posting upcoming events and all are welcome to volunteer to earn vouchers to use toward club trips.

Facebook Report: Gary Johnson reported that Liking and Sharing our Facebook page is a great way to reach people.

Biking/Website Report: Bill Bail reported biking was over and will pick up next summer.

Marketing/Merchandising: Gail Vogt reported on the CMSC trip event – Welcome Back to Cockaigne on January 25. She is pushing for a south pick up point at Arlington Rd. There will be Cleveland East and West side pickups. Fagowees will provide beverages/treats and pajama party is the theme for the bus ride. Gail noted that she was not able to attend the Ski Swap & Fall Fest October 11-13 but heard from volunteers that there were more ski clubs in attendance. It was suggested that a switch to put tables outside with the activities would bring more foot traffic. Buckeye Sports did not have their usual tent at the Fall Fest and their contract was not renewed with BMBW. There will be a logo branded shop instead at the resorts. Gail handles merchandising and will take special orders from catalogs. You can also bring your own merch to have the logo put on and she can usually have it back to you by the next meeting.

Membership: Debbie Scherer reported she has 128 paid members and reminded everyone membership dues should be paid by October 31. She reported she has 11 new members. She also noted she sends updated membership lists to trip leaders to check that trip attendees are paid members.

Newsletter Report: Mike Bishop was absent but has been busy with the constitutional review updates.

Social Chair Report: Diane Marzec reported there are two socials for October. Dinner at Don Pancho's October 19th after the Ski Shack's Open House. RSVP to Diane to be included in the dinner count. October 30th at Shale Brewery will be a Halloween themed/costume contest social. Costumes not required to participate. It was noted there is a social at Royal Docks Brewery on November 12 and also the Warren Miller Film at Akron Civic Theatre is November 23 and if there is enough interest Diane can make that into a social/dinner meetup.

Trip Committee Report: Scott Hunsinger reported that Gail did a great job setting up the wine tour and it might become an annual event. Scott Hunsinger called for the following trip reports:

Peak n Peek, NY Jan 11 \$77 Trip Leader Scott Hunsinger reported 10 people signed up.

Holiday Valley/Holimont Jan 15-17 \$285 Trip leader John Masalko reported he has 54 signed up for one full bus and is starting on filling a second bus.

Party theme is National Lampon Animal House, watch the movie again for character ideas but remember – No Food Fights – we want to be welcomed back.

Okemo, VT Feb 2-Feb 7 \$1,279 Trip Leader Scott Hunsinger reported 30 people are going, 8 driving, 22 flying. There is room for 10 more but he can only hold air for so long so contact ASAP to get on trip.

Seven Springs, PA Feb 14 \$75 Trip Leader Janet Brunecz reported she has 18 signed up. The theme will be Ski with a Heart On in observance of V-Day.

Holiday Valley, Feb 28 \$88 Trip Leaders Jeri & Gary Johnson. Jeri reported they have 11 signed up and there will be a dinner stop in Ellicottville.

Holimont, March 6 \$88 Trip Leader Roberta Graham. Scott reported she has 7 people signed up and there will be a dinner stop in Ellicottville.

Lake Tahoe, CA Mar 14-21 \$1,520 Trip Leader Art Pokopac. Art reported they are flying United and he has 32 going.

Cabo, Mexico January 21-28 \$1,439 All Inclusive, Trip Leader Bill Fry reported that he has one member who paid for most of the trip using the trip discount vouchers. He also mentioned he has 12 spots left on the Ireland/Scotland trip for 2020 and is taking deposits. Contact him for more information.

Old / New Business

Constitutional Review: Jason Stephan stated that copies of the proposed constitution changes were provided on the tables for members to follow along with as he reviewed them. He noted the goal is to have everything finalized for the next newsletter so they can be voted on at the December meeting. Most changes involve language and inclusivity. Other changes include adding vaping to the tobacco products section, having all members pay their membership (previously Executive Committee and Board Members were comp'd membership) and making Membership align with the Fiscal Year. These changes can't be put in effect until they've been voted on so expect any changes won't take effect until the 2020/2021 Season. We may carry members of good standing for 6 months of membership when the membership alignment to June 1 occurs.

Ski Shack Open House: Joyce Tolerton reported that while the Ski Shack Open House will be October 19-20, the club discount applies all year for members. She stated the Captain will be at the Open House. She has new Blizzard Skis and is carrying the Carbon Clothing Line. Joyce also mentioned that she has outstanding older gift certificates that were door prizes so check your stash and see if you have any of those to spend.

Meeting Adjournment

Meeting was adjourned at 8:15 p.m. Motion to adjourn was made by Al Brancifort; seconded by Ida Lesh and was followed by door prize drawings. Beth Souers won the 50/50 raffle.

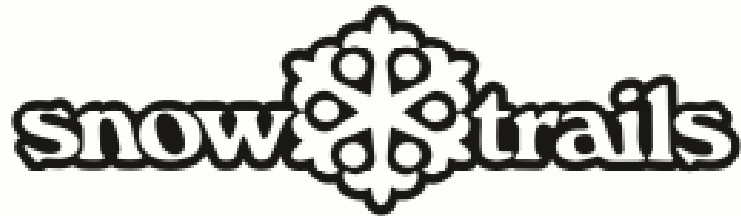

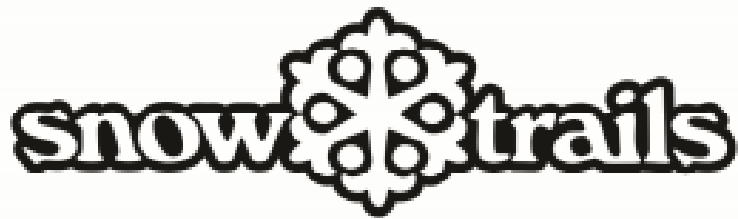

This Constitution, a complete revision of the previous one representing the former Timken Ski Club, is effective at midnight on May 20, 2014. (This revision was predicated on the required name change by directive from the Timken Company.)

ARTICLE II DEFINITIONS AND CONVENTIONS

Section A: Member

Membership shall be open to any adult (over age 18) eighteen (18) years of age or older, regardless of age, sex, race, religion, ethnic origin, political or sexual persuasion.

Membership in the *Club* shall be limited to those persons eighteen (18) years of age or older *except that a child under the age of eighteen (18) years may be a member under a family membership.* Persons under the age of 18 shall have the signed consent and be accompanied by a parent or guardian, as a prerequisite to participate in any *Club* activity. A minor, who is a member under a family membership shall, as a prerequisite to participate in any *Club* activities, have a signed application and consent and be accompanied by a parent, legal guardian or designee who is also a member of the *Club*, and shall be responsible for the minor during the *Club* activities.

ADULT: An adult is a person of the age of 18 years or more.

MINOR: A minor is a person below the age of 18 years

CHILD: A child is a descendent in the first degree of an adult, including a child by adoption, of the age of 25 years or under

FAMILY: One or two adults living at a single residence address with one or more children residing at the address, who are children of at least one of the adults living at the address. Family may include grandchildren who reside with a grandparent, who is their legal custodian, at the same residence address.

STUDENT: Is an adult of the age of 25 years or under, who is attending a two year or four year college or any other course of study or instruction for specialized, vocational, or professional training, at an accredited institution, whose principal place of residence is a with a parent at the parent's residence address.

HOUSEHOLD MEMBER: Is an adult of the age of 26 years or older, who resides at the same residence address as their parent. Said household member may not be a member of the *Club* under a Family Membership, but must maintain their own club Membership.

Section B: Board of Directors

The "Board of Directors" hereinafter referred to as the "*Board*" shall consist of the current officers, the previous two presidents president and current committee chairs. The purpose of the *Board* shall be to provide continuity and longevity to the *Club*, be responsible for the proper execution of the Constitution, and to recommend certain matters which are not normal day-to-day affairs. Only Executive Committee Members have voting rights on all issues before the *Board*.

Section E: Officers

The officers of the club shall be the President, Vice President, Secretary and Treasurer who shall be are elected by the membership body from nominations of the membership or from nominations of the *Board*.

Section F: Executive Committee

The "Executive Committee" hereinafter referred to as the "*Ex. Comm.*" is a permanent and standing sub-committee of the *Board*. The *Ex. Comm.* shall consist of the Current Officers and the previous two presidents president. All members have a committee vote. Actions require a quorum of three (3) and a majority vote of these present. Voting by e-mail is permitted.

Section G: Membership Committee

The President may appoint a Membership Chairperson. That chairperson may enlist other members for the work of retaining, documenting and expanding the *Club's* membership. The Membership Committee is also responsible for bringing to the attention of the *Board* all individuals who have not renewed their memberships by November August 1st of any year.

Section I: Membership Year

Begins on November June 1st and ends on October May 31st.

Section J: Addresses of Record

Refers to electronic as well as domicile address. These are the most recent of the addresses furnished on a membership application, published in the On-Line Membership Directory or communicated to the Secretary, the member publishing the Directory or the member maintaining the electronic mailing list.

Section K: Communication Conventions

The term mail may mean either electronic or postal mail. The preferred and official method of communication to members shall be electronic notification that the *Club's* newsletter is available on the *Club's* website. An email that is sent to a member's email Address of Record is considered as received if it is not returned as undeliverable by that member's Internet Service Provider. Members are responsible for notifying the *Club* of any changes of addresses.

Other methods of communication, although unofficial, are by posting on the *Club's* Website, Facebook, or through written or oral communication at a General Membership Meeting or *Club* event. The *Board* reserves the right to charge members for mailings outside the normal conventions at a price to be determined by the *Board*.

Section M: Website

starkcountyskiclub.com starkcountyskiclub.org is the official website of the *Club*. All information about the *Club* is posted under various "tabs". The site is maintained by the Website Manager.

Section P: Cleveland Metro Ski Council

The Cleveland Metro Ski Council is an umbrella organization of ski clubs primarily located in the northeastern Ohio region. Stark County Ski Club is a member and participates by having a member, traditionally the Vice-President or Executive Board designee as a Committee Chairperson whose title is CMSC Delegate, attend their Board meetings. The Executive Board reserves the right to review on an annual basis the SCSC need of position within the council.

ARTICLE III MEMBERSHIP

Section A: Membership Requirements

Section A-1 (Age):

Membership shall be open to any adult eighteen (18) years of age or older (over age 18), regardless of age, sex, race, religion, ethnic origin, political or sexual persuasion.

Membership in the *Club* shall be limited to those persons eighteen (18) years of age or older except as provided herein. Persons under the age of 18 shall have the signed consent and be accompanied by a parent or guardian, guardian, or designee as a prerequisite to participate in any *Club* activity.

Section A-3 (Renewal):

Membership applications/renewals will be made available to members via the Tips & Tails Newsletter. Renewal dues are payable to the Membership Committee November June 1st. The Membership Year begins on November June 1st and ends on October May 31st. Membership renewal is conditioned upon the timely return of an application and the payment of membership dues. If renewal of membership is not received by November August 1st, the membership will shall be considered terminated, and any membership renewal received after that date shall be deemed a new membership and appropriate fees will apply be charged.

Section A-4 (Dues):

The *Board* shall vote on the schedule of dues for each type of membership as proposed by the Membership Committee before August March 1st of each year.

The current year's officers shall receive a year's free membership at the first renewal date following their appointment.

The current year's editor, web director, circulation person, CMSC delegate and other individuals as deemed by *Ex. Comm.* to provide a beneficial service shall receive a year's free membership at the first renewal date following their appointment.

Past Presidents shall receive two (2) years of free dues immediately following their term or if elected to any other office immediately after their Presidential term, for two years after that term of office.

Section A-5 (Application):

Membership shall be by application, together with the appropriate fee and signed liability waiver. Membership shall become invalid when a member no longer meets these requirements. The Membership Committee is responsible for updating the application form annually with a current dues schedule incorporated and publishing it on the Website and in the Newsletter on or before August March 1st of each year.

Section B: Types of Memberships

Section B-1 (Voting):

The following types of memberships are voting members of the *Club*:

Single Members = One person Single Membership shall be available to a single adult.

Couple = Husband & Wife or Partners sharing a single address Couple Membership shall be available to two adults permanently residing at the same address.

Family = Couple or Parents and children who are under 18 or are full time students

Family Membership shall be available to one or two adults living at a single residence address with one or more minor children or students residing at the same address, who are children of at least one of the adults living at that address. Family may include grandchildren who reside with a grandparent, who is their legal custodian, at the same residence address.

Section B-2 (Non-voting):

Non-voting members are Family members who are under the age of 18. Non-voting members may not be nominated for or elected as officers or to the *Board*.

Section B-3 (Trips and Activities):

Non-members participating in any *Club* trip or activity must sign a *Club* liability release form and abide by the *Club*'s Constitution and Regulations. They must pay additional non-member fees for the trips or activities as determined by the *Ex. Comm.*

Section B-4 B-3 (Other):

The *Board* may create other types of voting and non-voting memberships.

Section D: Membership Revocation

Section D-1 (Revocation):

Any member in arrears for dues as of August 1, or other indebtedness to the *Club* may shall be denied the rights of a member or and have their membership revoked.

Section D-2 (Detrimental Conduct):

The *Ex. Comm.* may revoke the membership of any member, elected, or appointed position who has engaged in behavior or conduct detrimental to the *Club*.

Section D-3 (Conduct):

Members should adhere to local laws concerning smoking, vaping, tobacco products wherever the *Club* is having an event. Beyond the law, there shall be no smoking, vaping, tobacco products or use of illegal drugs on any bus or at any club meeting of the Stark County Ski Club. Smoking members Members should be courteous in regards to smoking the use of all products noted prior, even outdoors when non-smoking members are present.

ARTICLE IV GOVERNMENT

Section A: Board of Directors

Section A-3 (Minutes):

A summary of the minutes of a *Board* meeting may be included in the Newsletter by the Secretary. The President may also include a summary in his oral report at the general business meetings. Personal details may be excluded, but the **names of Directors who voted** **vote results** for or against issues should be included in the official minutes. The purpose is to inform the membership of issues discussed by the *Board* and the actions taken.

Section B: Executive Committee

Section B-1 (Members):

The *Ex. Comm.* is a permanent and standing committee of the *Club* consisting of the current officers and the previous **two** presidents.

Section C-4 (Treasurer):

The Treasurer's duties are to include but not be limited to:

- Accounting for accurate and current financial records
- Reconciling of the *Club* bank statement monthly
- Receiving monies from membership and committee chairs paid to the *Club* for participation in activities
- Depositing all funds received and handles all transactions related thereto
- Preparing monthly reports of receipts and expenditures
- Keeping all financial records and maintaining an inventory of all *Club* financial property for a minimum of seven (7) years.
- In a timely manner, preparing and filing all required Federal, State, local tax and information returns
- Record certificate vouchers as assigned to each SCSC appointees as determined by the Ex. Board**

Section D: Trip/Activity Committee

The Trip Committee shall consist of 5 members: a Trip Chairperson and 4 other Club members, each in good standing.

Elections for the Trip Committee members shall occur at the regularly scheduled meeting in **November April** each year. All Club members present at that meeting may vote.

Section G: Compensation/Trip Discount Certificate Vouchers

To encourage Club members to be active and participate in the government of the Club, **members shall be compensated according to the following schedule members who are officers shall receive the following :**

President	\$500 credit towards trips and activities of the <u>Club</u> during their term and free membership during her/his term and for the next 2 years as Past President.
Vice President	\$400 credit towards trip and activities of the <u>Club</u> during her/his term and free membership for that term.
Treasurer	\$400 credit towards trips and activities of the Club during her/his term and free membership during that term.
Secretary	\$300 credit towards trips and activities of the Club during her/his term and free membership for that term.
Trip Chairperson	\$125 credit to be used for Club activities or merchandise. And, the opportunity to participate in the Mountain Travel Symposium and "FAM" trips, with or without full or partial reimbursement by the Club.
Trip Committee	\$75 credit to be used for club activities or merchandise.
Webmaster	\$250 credit to be used for Club activities or merchandise.
Newsletter Editor	\$125 credit to be used for Club activities or merchandise.
Membership Chair	\$125 credit to be used for Club activities or merchandise
Marketing Manager	\$125 credit to be used for Club activities or merchandise
Social Events Manager	- \$125 credit to be used for Club activities or merchandise
Merchandise Manager	- \$125 credit to be used for Club activities or merchandise.

e. Any additional appointees as determined by the President or the Board (eg. **Parliamentarian, Financial or Legal Advisor, Facebook Manager, Biking Manager**) shall receive \$50 credit **in an amount to be determined by the Executive Board** to be used towards club activities or merchandise.

Trip/Activity Leaders:

One day trip leaders will be fully compensated for the cost of trip; lifts, transportation and any travel fees. Their trip is free.

Multi-day trip leaders (at least 2 days of skiing) will receive \$150 credit to be used toward club activities or merchandise.

Week trip leaders will receive a credit amount equal to free lift ticket for the number of days skiing the trip has assigned. Minimum amount will be \$300.

Fund-raising Chair:

Shall receive a credit worth 5% of income brought in, not to exceed \$250.00, to be used for club activities or merchandise.

No cash compensation will be paid to officers or trip leaders. **At the end of the Club season, any unused compensation credit will be forfeited.**

Compensation or All credits or rewards issued listed above as determined by the Executive Committee are valid as long as they do not exceed the total amount of income from Club memberships in the given fiscal year. Should the membership income decline to less than the **credit or reward compensation** outlay, the **credit or reward compensation** formulae shall be changed so as to not exceed said income. The new **credit or reward compensation** formulae shall be determined by the Executive Board and approved by the Board of Directors and **then brought forth to the General Membership at the 1st available meeting.**

ARTICLE VIII AMENDMENTS

Section A: Amending

Proposed amendments must be presented in writing to the *Board* or to the General Membership at a General Business Meeting. Proposed amendments must be presented by a voting member at least one (1) month prior to the vote for consideration by the *Board* and General Membership.

Proposed amendments, in complete form, must be placed in the Club newsletter at least one (1) month prior to adoption.

Amendments to this Constitution can be adopted at any scheduled meeting of the *Club* Membership by a two-thirds (2/3) affirmative vote of membership.

Upon an affirmative vote of two-thirds of the membership present at the designated meeting, the proposed amendment shall be incorporated into the Constitution.

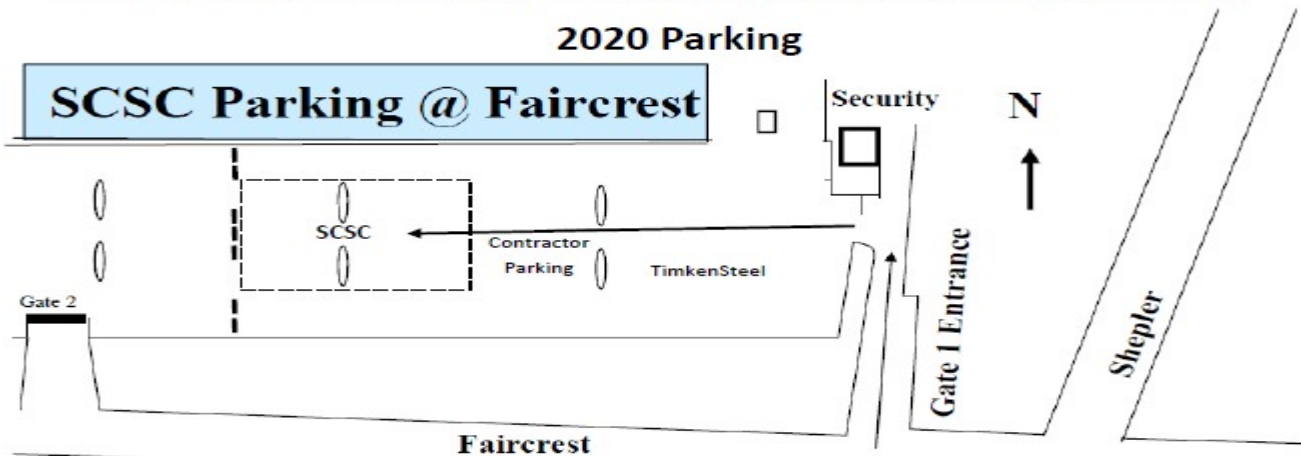

The Standard Operating Procedures (SOP) shall be reviewed with the constitution or as needed. The formation of the Review Committee and the review of this Constitution shall not be interpreted to imply that changes in this Constitution are required or necessary.
