It causes a bookkeeping/accounting nightmare for the trip leaders and also the treasurer.

Your MEMBERSHIP DUES need to be a SEPARATE PAYMENT too.

View From The Top By: Jason Stephan

If your mailbox, inbox, and Facebook feed look anything like mine, there's no denying that fall is here and winter is just around the corner. You just may want to look at some of those offerings and deals out there. Now is the time of year to pull your skis, boots, and winter clothing out to check for closet shrinkage, rust from being hastily put away at the end of last season, skis will need a good tune, bindings will need to be checked for proper function. Some of you may want or need to upgrade equipment, and while early or preseason sales may not be as deep a discount as those late-season deals the selection is much greater.

Those who attended the first meeting of the season met some new faces and learned all about the work done over the summer. For those who missed the meeting here are a couple of highlights. Some of the changes we are proposing to the constitution are changing the membership renewal date from November to June, this won't happen before this November, so all members need to make sure that your membership is renewed before the deadline date, as you will be considered a member in good standing and not a new member. As we are looking at if this passes the constitutional process the club will extend your membership for an additional six months before membership renewal is due again June 1st. Also proposed a change to have all members required to pay yearly membership and sign our standard membership release (all offices included). Most other changes will be in the language used throughout the constitution keeping us up to date with the 21st century and to ensure that we remain a 100% inclusive club. Our seasons' ski schedule was announced, and we heard from all of the trip leaders for these seasons' offerings and learned of a great non-ski trip announcement going to Ireland and Scotland in September of 2020. Trip discount vouchers earned by working events at Tom Benson can be used but you need to start earning them now, as waiting till next year will be too late.

It was learned that we will not be holding the Winterfest at Quaker Steak and Lube this year and will be combining our annual Kickoff party with our open house. So yes, bring a friend/guest to find out more about us and who we are. We will be having some smaller scale informal winter fest gatherings at some local breweries that will combine with a group social. Keep your eyes on your email inbox and Facebook feed as these events will be mostly advertised through social media. We will be attending the rebranded 2019 ski swap and fall fest October 11-13th and we'll need some club members to volunteer to represent the club and interact with the public. Those who can lend a hand contact Gail Vogt or I and we can schedule you to represent the club. The club will host Cleveland Metro Ski Councils November 7th meeting, at Mulligans in Belden Village at 7:30 pm, those who wish to attend please contact Vice president Jeri, CMSC rep Gail Vogt or myself, email me at president@starkcountyskiclub.org and I will forward your email to Jeri and Gail.

Let's hope for early snow!

Call to Order

President Jason Stephan called the meeting to order at 7:00 p.m. He asked first time attendees to introduce themselves and Jessie (invited by the Gonyias'), Ed and Inge (Panorama trip) were welcomed. Fifty-five (55) individuals were in attendance. Jason called for the following reports:

Officer / Chair Reports

President Report: Jason Stephan reported there won't be a Winterfest at Quaker Steak, but we would have smaller outings at local breweries/wineries with club information available. He noted that our best marketing tool is our members and we can be accessible during our social events.

Jason passed out certificates to Officers and Chairpersons.

Vice President Report: Gail Vogt reported for Jeri Johnson that the Kick-off the Season party will be December 1st at The Barrel Room from 5-9:30pm. The Club will provide chicken and pizza; members are asked to bring a covered dish. We have found most new members find us by word of mouth and there will be incentives to bring friends. Please RSVP to Jeri so they can plan for food. If you are interested in a name tag, Jeri is taking orders and they cost \$7.50. Jeri attended the September CMSC meeting and reported there will be a "Welcome back to Cockaigne" trip January 25 with north and south pickups. The Sitzmark is having publication issues and CMSC may turn to a newsletter format like the SCSC newsletter. CMSC was running three trips but their Lake Tahoe trip is joining our club trip. There are now two CMSC trips, Breckenridge running January 22-27 and Austria (sold out) running January 31-February 8. CMSC will hold their November 7 meeting at Mulligan's and you are invited to attend.

Treasurer Report: Melba Gasque reported on the amount in the club treasury and noted money will soon go out for trips. Melba gave a comparison of end of the Fiscal Year amounts for 2018 and 2019, which were very close and said there are outstanding vouchers that would bring the balance down.

Secretary Report: Jennifer Stephan reported she had \$156 in the 50/50 raffle. Jennifer noted she was interviewed at the HOF parade and a small blurb appeared in the special parade section. It highlighted how the club fills community event needs.

Facebook Report: Gary Johnson reported that Facebook continues to receive traffic and he will post Socials, Trips, Events for more exposure.

Biking/Website Report: Bill Bail was absent, but it was reported most rides this year were either wet or hot.

Marketing/Merchandising: Gail Vogt reported the BMBW Open House has been re-branded as a Ski Swap & Fall Fest on October 11-13. Volunteers are needed to man the club table. Gail reported she is working to get the clubs back that were banned or lost interest to get more foot traffic visiting club tables. This is also a fundraiser for Ski Patrol, you can sell equipment by dropping off during these hours (10/7 12p-9p; 10/8&10/9 10a-9p; 10/10 10a-5p and 10/11& 10/12, regular open house hours. Gail is also handling merchandising and will take special orders, she has catalogs you can look through. You can also bring your own merchandise for embossing which doesn't cost much, about \$5. If you are interested in leg bands, she can also place a special order for those.

Membership: Debbie Scherer reported there have been 8 new members. Please remember membership dues should be paid by October 31.

Newsletter Report: Mike Bishop reported he has been working on the constitution review and to please be prompt with newsletter contributions.

Social Chair Report: Diane Marzec reported she has a social planned Monday, Sept 23 at the Crush House. She will also run a social with The Ski Shack's Open House October 19, 20. RSVP to Diane to be included in the dinner count at Don Pancho's Oct. 19. Diane reported there was not enough interest to follow through with the golf scramble so it is cancelled. Gail is running the wine bus tour on October 5 and has 33 people signed up and can upgrade to a larger bus if more interest. \$35 for your seat on the bus/DD. It will stop at wineries, a brewery and a distillery on the Three Rivers Wine Trail.

Trip Committee Report: It was noted there were previous trips canceled not because of weather, but because people didn't sign up in time to fill the bus before the cut-off date to cancel without penalty. Thus, with Blossom money and now Benson money, Early Discount Vouchers are available to get busses filled before they need cancelled. It was noted that vouchers are for bus trips only and not self-drive. Scott Hunsinger called for the following trip reports:

Trip Reports

Peak n Peek, NY Jan 11 \$77 Trip Leader Andy Findlay reported 4 signed up.

Holiday Valley/Holimont Jan 15-17 \$285 Trip leader John Masalko reported they have 50 rooms reserved and two busses. There are 30 people signed up and the party theme is National Lampoon Animal House.

Okemo, VT Feb 2-Feb 7 \$1,279 Trip Leader Scott Hunsinger reported 30 people are going, 8 driving, 22 flying. There is room for 10 more but he can only hold air for so long so contact ASAP to get on trip.

Seven Springs, PA Feb 14 \$75 Trip Leader Janet Brunecz reported she has 8 signed up. The theme will be Ski with a Heart On in observance of V-Day.

Holiday Valley, Feb 28 \$88 Trip Leaders Jeri & Gary Johnson. Gary reported they have 7 signed up and there will be a dinner stop in Ellicottville.

Holimont, March 6 \$88 Trip Leader Roberta Graham reported she has 2 people signed up and there will be a dinner stop in Ellicottville.

Lake Tahoe, CA Mar 14-21 \$1,520 Trip Leader Art Pokopac. Art reported air has not been released yet and the price could change. He also reported that he picked up six people from a CMSC Tahoe trip that has been cancelled. The hotel is close to the Heavenly Lift, shopping and gambling.

Cabo, Mexico January 21-28 \$1,439 All Inclusive, Trip Leader Bill Fry reported 8 club members are going of the 32 signed up. There is still room for 2 but air will be released shortly so contact ASAP to get on trip.

Old Business

Constitutional Review: Jason Stephan reported that the Executive Comm, Board and interested members, had met several times over the summer for a constitutional review. Most changes involve language and inclusivity. Other changes include having all members responsible to pay their membership (previously Executive Committee and Board Members were comp'd membership) and making Membership align with the Fiscal Year. These changes can't be put in effect until they've been posted, presented and voted on which should happen by the December meeting. This means changes would take effect for the 2020/2021 Season. We may carry members of good standing for 6 months of membership when the membership alignment to June 1 occurs.

Fundraising: Donna Brancifort handed out \$7,443 in trip discount vouchers to workers. She stated that we are recognized as a great group of workers by many within the AVI organization. She will be keeping posting upcoming events and all are welcome to volunteer to earn vouchers to use toward club trips.

SnowTrails: Andy Findley presented season pass information for Snowtrails in Mansfield. He noted there is a \$10Lift,\$10Rental,\$10Lesson promotion which can be used once. Please contact Andy if you have questions, would like to get a pass application, or learn more about the 3/\$10 each deal.

Miscellaneous: The Ski Shack Open House will be October 19-20. Bill Fry is putting together an Ireland/Scotland trip and is taking names for those interested. He believes a contract will be signed by the October meeting and he will take deposits (\$300 for initial) for the 24 spots he has available. Vouchers will be accepted after the deposit.

Meeting Adjournment

Meeting was adjourned at 8:10 p.m. Motion to adjourn was made by Mike Bishop; seconded by Art Pokopac and was followed by door prize drawings. Alyssa Givens won the 50/50 raffle.

Concerning the CMSC website, the source was sold this summer and it was down during the summer. It is up again but at a higher fee. They are looking into another domain for next year.

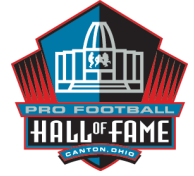

They are advertising craft beers on site and more types of food, music, demonstrations, and hoping for more club's to be present.

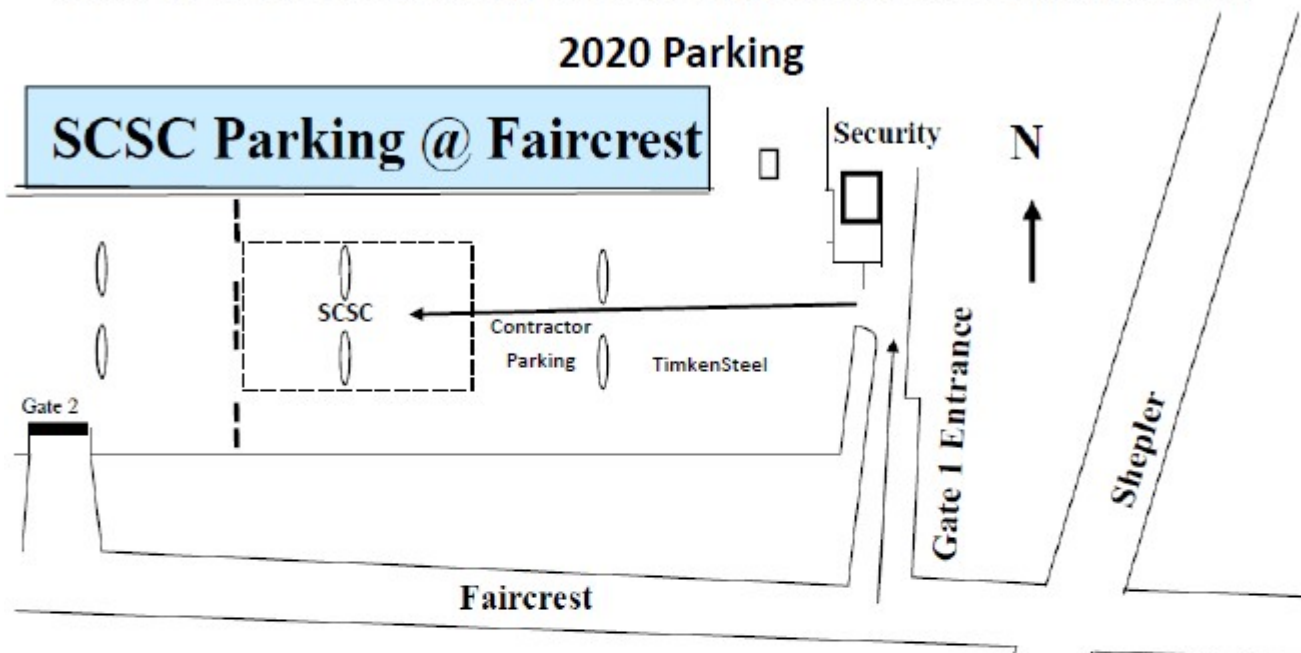
We have a table to support club's information, and we need a few more people to be at it to talk to people about the club's activities and ski trips for 2020.

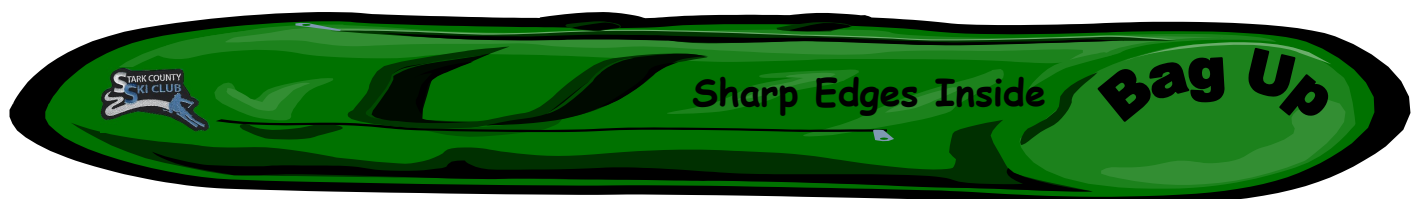
Preseason shopping might include some new Skis?, Boards?, Boots?... Don't forget **BAGS!**

If you're as passionate as I am about skiing you prepare for ski season all year round. That probably includes planning a ski trip budget, working-out, tuning your gear, or maybe investing in new gear. Lets protect your investment of time in tuning, or new gear by bagging your equipment.

Stark County Ski Club trips are scheduled well in advance and priced based on number of participants, number of bus seats available and cost of bus transportation services. Bus size needs are determined by the number of people, length of trip, and estimated amount of passenger luggage (ski bag, boot bag, and one piece of luggage, as the trip requires).

- All skis/snowboards and all ski /snowboard boots must be in a proper equipment bag.
- Unless the trip leader indicates that space is available inside the bus, all baggage stated above must be stowed in the bus baggage bays. If participants wish to have their ski boots on the bus, the boots must fit under their own seat.
- Unless indicated by the trip leader, a participant shall not place their boot bag on a seat next to them or a seat nearby. Bus seats are for people participating on the trips.
- Personal items (snacks/food, coolers, clothing items) are permitted on the bus as long as they can be safely stowed under the participants own seat or in the overhead compartment above their seat. The club may provide beverages and snacks depending on the trip destination and length.

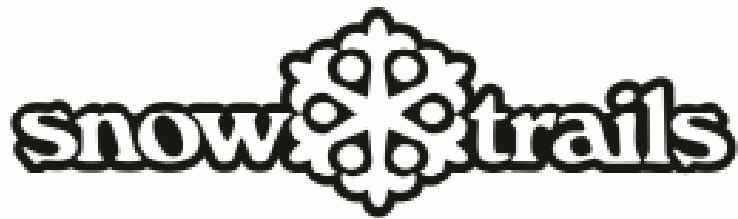

Any minor's participant's "Trip Application & Agreement" must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.

6. CANCELLATION & REFUNDS:

- A). Cancellation by participant means & includes: failure to abide by terms of this agreement, notice of intent to cancel; failure to make timely payments; failure for any reason to meet the departure or return of the trip.
- B). When SCSC cancels or withdraws a trip, the participant shall be entitled to a full refund unless such cancellation or withdrawal is necessitated or caused, in whole or part, by participant's cancellation or failure to make timely payments.
- C). Where participant cancels more than 30 days before departure of a 1-day or multi-day trip or more than 60 days before the departure of a longer trip, then participant shall be responsible for a cancellation service charge of not less than \$10.00 & any fees charged by an airline if seats have already been ticketed.
- D). Where participant cancels less than 30 days before the departure of a 1-day or multi-day trip or less than 60 days before the departure of a longer trip and where the trip departs full or where participant provides an immediate replacement who completes this agreement, then participant shall receive a full refund less the cancellation service charge & any fees accessed because of the name change. If the trip departs unfilled and the participant has not provided a replacement, then the participant may be entitled to a partial refund less any amounts pre-paid by SCSC for participant's unused transportation, lodging, meals, lifts or amenities and less the cancellation service charge. If the applicant cancels and the trip departs unfilled, the applicant will be refunded the amount of any un-purchased lift tickets. Transportation, lodging and other special costs may NOT be refunded. Specific trip circumstances will determine if any refund of these costs are possible. In any case, the participant is responsible to SCSC for any amounts paid out by SCSC over and above payments made by participant. Any pre-paid expenses that are not refunded to the club by the airlines, resorts, etc. are not subject to be refunded to participant. For 1- week or longer trips, it is advised to purchase trip insurance for refunds. SCSC may modify or change balance due dates & cancellation deadlines to accommodate its payments to airlines, lodges, bus companies and travel agents.

7. ELIGIBILITY:

Participation in this trip is first available to current SCSC members in good standing. After 30 days, trip will be open to new members. Membership must remain current throughout the ski season travel period.
