Those getting the Military Epic pass will have to go through Epic pass directly and not through a third-party seller. This makes prices for active/reserve and veterans truly epic. As September brings in the change of season to fall for us it will also bring in a little change as we welcome back Diane Marzec to the position of Social chair. I would like to thank Vickie Roe for the fine job she has done filling the big shoes left when Diane stepped down from the position a little over a year ago. **2. WITHDRAWAL & CHANGE:**

Stark County Ski Club (SCSC) may withdraw any trip from its schedule at any time; may refuse to accept or refrain any person as a participant at any time for any reason; and may change the itinerary at any time.
