Description of the biking program

2021 Beaver Creek Trip On-line Registration Instructions:

Please take note this is a preview for the instructions to registrar for the 2021 Beaver Creek

Speaking of a difference, the 2021 Beaver Ski trip will require on-line registration with the tour operator. The tour operator will oversee all terms and conditions of the trip. You will now be able to pay with a credit card with 3.3% fee, pay pal with a 2.75% fee, by check either mail in or phone in check nos. The trip has a base price which includes lodging, flights and bus transfers. You will be able to pick your Epic lift ticket either multi-day to the Epic pass (a few choices). Also, you will be able to pick, two types of insurance or decline insurance. Both these choice will affect the final price of you trip. Remember insurance is highly recommended but does not cover an epidemic but when it comes down to terms and conditions of trip, the tour operator will be in charge, not Stark County Ski Club.

A 4-day restricted pass is the suggestion.

To maneuver yourself to the next page, click on items and click green box to continue at bottom on box.

Next page is the Travelers Information

Fill traveler's information for each person: adult season pass (Epic) and Stark Ski Club

Name as it appears on your id – first and last name

Then birth date.

Information will be used for TSA

Next page is the Checkout

This page will give a summary of what you have pick, plus insurance and information to fill out

Now your three choices on travel insurance (Highly recommended):

Good idea – Standard Insurance policy

Even Better – Cancel for any reason policy

Neither policy covers an epidemic

Decline insurance – read carefully tour operator terms and conditions apply, cancel is controlled by tour operator.

Credit card - 3.3% fee

Pay Pal - 2.75% fee

ACH – no fee – call check nos into tour operator

Check – no fee – send check to tour operator, usually 5-days for delivery

This will also tell you, your deposit and final balance and when balance is due.

After confirmation, all payments except vouchers will be directed to Ski.com, not Stark County Ski Club.

People with vouchers, please send to trip leader and the club will send the amount total of your vouchers that will be sent to the tour operator for credit on the trip. Remember if trip is cancelled and you paid with Vouchers, your refund will be in vouchers.
