Did SANTA bring you some new Skis, Boots, or a personal refreshment **BAG**!

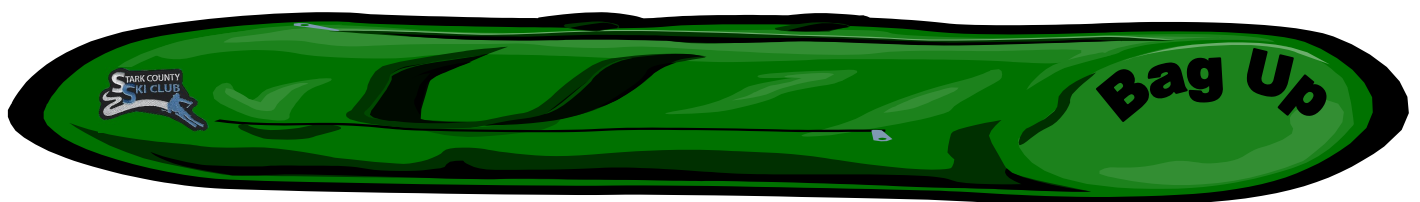
If you are as passionate about skiing as I am you prepare all year round for ski season. That probably includes planning a ski trip budget, working-out, tuning your gear, or maybe investing in new gear. Lets protect your investment of time in tuning, or new gear by **bagging** your equipment.

Stark County Ski Club trips are scheduled well in advance and priced based on number of participants, number of bus seats available, and cost of bus transportation services. Bus size needs are determined by the number of people, length of trip, and estimated amount of passenger luggage (ski **bag**, boot **bag**, and one piece of luggage (a.k.a. **BAG**), as the trip requires).

- All skis/snowboards and all ski /snowboard boots must be in a proper equipment bag.
- Unless the trip leader indicates that space is available inside the bus, all baggage stated above must be stowed in the bus **baggage** bays. If participants wish to have their ski boots on the bus, the boots must fit under your own seat.
- Unless indicated by the trip leader, a participant shall not place their boot **bag** on a seat next to them or a seat nearby. Bus seats are for people participating on the trips.
- Personal items (snacks/food, coolers, clothing items) are permitted on the bus as long as they can be safely stowed under the participants own seat or in the overhead compartment above their seat. The club may provide beverages and snacks depending on the trip destination and length.

Online Trip Application Notes

After completing the SCSC trip application online you should receive an email confirmation from the Trip Leader within 48 hours. If you do not, contact the Trip Leader immediately by email. SCSC Trip applications and payments need to be officially received in order to reserve your position on all trips. If you are on a waiting list the Trip Leader will inform you of your position.

Call to Order

President Jason Stephan called the meeting to order at 7:00 p.m. Fifty-one (51) individuals were in attendance. Jason asked for new members or visitors to introduce themselves. Brian Freeh and Greg McKenna stood up and were recognized.

Officer / Chair Reports

President Report: Jason Stephan stated that the Benson / AVI season finished strong and thanks to volunteer efforts since fundraising started with Blossom, trips have been kept affordable and running. Since implementing early trip sign up discounts no trip has been canceled due to low participation, only because of weather. Jason reported that 20 plus volunteers from the Club traveled to Solon on December 14 and helped build over 1,000 bikes with the group, Elves & More.

Jason noted membership should have received an email from him with the Sitzmark attached. This is the new format going forward.

Jason called for the following reports:

Vice President Report: Jeri Johnson reported that the Kick-off the Season party on Dec. 1st at The Barrel Room was a great success and that Donna Brancifort won the gift voucher from the Toy Drive and Beth Souers won the 50/50. Leftover chicken was donated to the Canton YWCA shelter. \$495 and 38 toys were donated to the Toys for Tots toy drive which brings the Club's four-year total to \$2,000 in cash and 350 toys donated. It was mentioned there is no CMSC December meeting but the holiday party at Slyman's in Independence is scheduled for December 19. RSVP's were requested by December 10 but if you have an interest in going, email Curtis Bell at curtisemsc60@gmail.com.

Treasurer Report: Donna Brancifort reported on the treasury amount for Melba, who is out of town for a few months. She noted as always, money will be coming in and going out fast for trips.

Secretary Report: Jennifer Stephan reported she had \$140 in the 50/50 raffle and would sell more tickets before the drawing.

Fundraising Report: Donna Brancifort handed out \$3,150 in trip discount vouchers to 21 people who participated in the 3 days of state finals and a playoff game at Akron. This brought this year's total of vouchers handed out to \$13,800+. Donna reported last year we raised \$23,000 but the volunteer numbers were down this year for state tournaments and money may not go that high. Even so, the stand sold over \$55,000 of food over 3 days. Donna would like to see more volunteers for next year so other groups are not lumped into our stand.

Facebook Report: Gary Johnson reported that Jason had posted pictures from the bike build and it reached 284 people. An article about Klaus Obermeyer turning 100 and still skiing reached 726 people this month. Continue to Like and Share posts.

Website Report: Bill Bail reported that with President Jason's approval, the contract with Go Daddy was renewed for 2 years. Jason noted that this keeps our email addresses with a .org ending which gives a more professional appearance.

Marketing/Merchandising: Gail Vogt reported there were no marketing updates. For merchandising, Gail showed examples of embroidered items and will take special orders, or you can bring your own merch to have the logo put on for \$3.30 for the embroidery. Turnaround for embroidery is approx. 10 days.

Membership: Debbie Scherer reported she has 223 paid members, 28 which are new.

Newsletter Report: Mike Bishop thanked everyone for last month's early submittals and asked that trip leaders send him updated trip counts. Mike stated that parking is in place for the season and he has updated the parking map, which is more detailed. He noted that everyone should pay attention to the parking perimeter and park east of the barriers. If you have questions when you get to Faircrest Parking, he should be there to help.

Social Chair Report: Diane Marzec reported there may be January and February socials held during the week and won't conflict with ski trips. She is looking at Fatheads or Table 6 as possible venues so keep an eye out for those emails. Diane mentioned a bed and breakfast in Orrville would like to give us a free venue for an event to help get their name out. Diane will look into putting something together, possibly March or April.

Trip Committee Report: Scott Hunsinger reported that tonight, December 17, is the last day to use the early sign up discount. They must be used towards the whole trip and are not valid for self-drive ups. Scott Hunsinger called for the following trip reports:

Holimont, March 6 \$88 Trip Leader Roberta Graham. Roberta was absent to report.

Lake Tahoe, CA Mar 14-21 \$1,520 Trip Leader Art Pokopac. Trip was cut down to 30 people and needs 1 male, contact Art.

Cabo, Mexico January 21-28 \$1,439 All Inclusive, Trip Leader Bill Fry.

Old / New Business

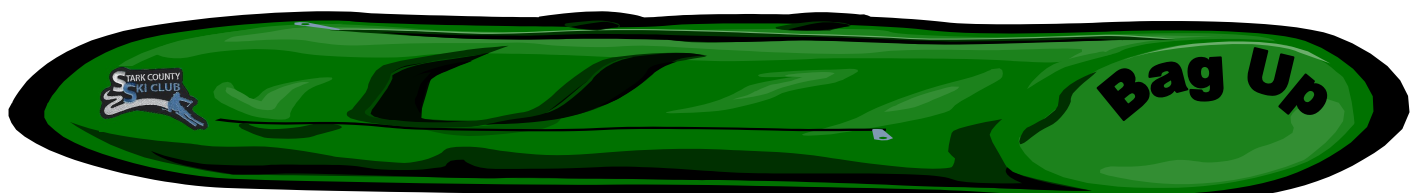

Please read and in designated question on the application, answer that you have read this document. The undersigned participant applies to participate in the Stark County Ski Club (SCSC) trip described below, subject to the following conditions:

1. PAYMENTS:

Trip deposits will vary per trip and must be paid and submitted along with this signed "Trip Agreement and Application" (below). Balance shall be due & payable in accordance with payment schedules established by SCSC & described in the trip description in "Tips & Tails", the club newsletter, or on the club website www.starkcountyskiclub.org. Charges may be added for supplemental costs such as fuel surcharges, taxes, single supplement for room and airport departure changes to the price of the trip. All payment checks shall be payable to "Stark County Ski Club" & sent to trip leader noted.

2. WITHDRAWAL & CHANGE:

Stark County Ski Club (SCSC) may withdraw any trip from its schedule at any time; may refuse to accept or refrain any person as a participant at any time for any reason; and may change the itinerary at any time.

3. RESPONSIBILITY:

Stark County Ski Club & TimkenSteel are acting gratuitously for the applicant and shall not be responsible or liable for any loss of or damage to any baggage, property, or for any loss, injury, death, accident, delay, inconvenience or any other loss occurring during or occasioned by an applicant's participation in any trip, and as a result of any actual or alleged negligence of SCSC or any SCSC member or officer.

4. IDENTIFICATION:

Participants are responsible for any required identification for travel. This may include, but not limited to, an up to date and valid passport, visa, drivers license or proof of identification and citizenship.

5. MINORS:

Any minor's participant's "Trip Application & Agreement" must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.

- A). Cancellation by participant means & includes: failure to abide by terms of this agreement, notice of intent to cancel; failure to make timely payments; failure for any reason to meet the departure or return of the trip.
- B). When SCSC cancels or withdraws a trip, the participant shall be entitled to a full refund unless such cancellation or withdrawal is necessitated or caused, in whole or part, by participant's cancellation or failure to make timely payments.
- C). Where participant cancels more than 30 days before departure of a 1-day or multi-day trip or more than 60 days before the departure of a longer trip, then participant shall be responsible for a cancellation service charge of not less than \$10.00 & any fees charged by an airline if seats have already been ticketed.
- D). Where participant cancels less than 30 days before the departure of a 1-day or multi-day trip or less than 60 days before the departure of a longer trip and where the trip departs full or where participant provides an immediate replacement who completes this agreement, then participant shall receive a full refund less the cancellation service charge & any fees assessed because of the name change. If the trip departs unfilled and the participant has not provided a replacement, then the participant may be entitled to a partial refund less any amounts pre-paid by SCSC for participant's unused transportation, lodging, meals, lifts or amenities and less the cancellation service charge. If the applicant cancels and the trip departs unfilled, the applicant will be refunded the amount of any un-purchased lift tickets. Transportation, lodging and other special costs may NOT be refunded. Specific trip circumstances will determine if any refund of these costs are possible. In any case, the participant is responsible to SCSC for any amounts paid out by SCSC over and above payments made by participant. Any pre-paid expenses that are not refunded to the club by the airlines, resorts, etc. are not subject to be refunded to participant. For 1- week or longer trips, it is advised to purchase trip insurance for refunds. SCSC may modify or change balance due dates & cancellation deadlines to accommodate its payments to airlines, lodges, bus companies and travel agents.

7. ELIGIBILITY:

Participation in this trip is first available to current SCSC members in good standing. After 30 days, trip will be open to new members. Membership must remain current throughout the ski season travel period.

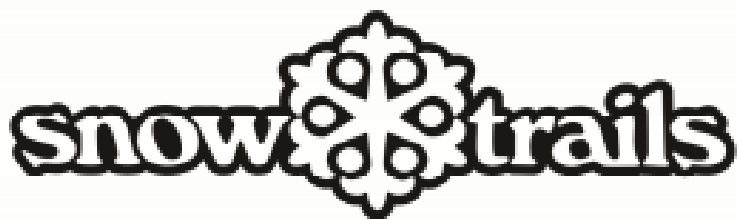
