I, for one, am looking forward to the end of the political rhetoric season. Time & choice, one we do not seem to have enough of, and the other may be too much of occasionally. We did choose to have our skis tuned some time ago, and our gear has been gone over in preparation for a ski season. I am planning on doing some ski pole distancing somewhere local this season, time permitting.

Thank you to those members who have reached out to let us know how we are doing. I have had a number of inquiries as to the club's direction this year due to Covid. As I explained in the monthly Zoom meeting, *the club is operated from a decision process out of the Executive Board through a quorum*. If you have an idea to share please do contact me or any other officer in the club.



This month I have included some of the links I visit to keep tabs on the outside ski world which is pretty much anywhere outside my house. I do this to see if other resorts adopt the procedure being developed out west. The following paragraph is an example of what you might expect.

Pro-tip: pack several face masks because you're going to need them everywhere. Facial coverings will be required while queuing for, loading, and riding lifts at every resort we spoke with. Windows will remain open on larger trams and gondolas to keep fresh air circulating, such as in Big Sky. Resorts are doing away with the singles line, won't be enforcing max capacity on lifts, and are letting guests have a say in who they want to share the lift with. "For lifts and gondolas, the rule of thumb is to ride with who you came with," says a spokesperson for Idaho ski resorts. Some destinations, like [Breckenridge](#) and Aspen Snowmass, are also taking added precautions with mandatory mask zones in their downtowns that require masks to be worn at all times, both indoors and out, while in town.

**Call to Order:** President Michael Bishop called the meeting to order at 7:00 p.m. He welcomed attendees and reminded all they should have entered the meeting on mute. Mike noted only the recognized individual will have the floor. Mike Bishop asked for a motion to not review September meeting minutes. Art Pokopac made the Motion and it was seconded Scott Hunsinger. Mike Bishop called for the following reports:

### **Officer / Chair Reports**

**President Report:** Under Old Business, Mike Bishop reminded [members paid up as of October 31, 2019; their membership is extended from November 1, 2020 to May 31<sup>st</sup>, 2021 at no additional cost. Mike reported under New Business that the Executive Board did not hold an October 2020 meeting but the SCSC trip budget was reviewed and accepted and as such was being brought to the membership at the first available meeting and is published in the newsletter.](#) Mike stated that Stark County Ski Club wants to continue moving forward during Covid and encouraged all members to use the electronic application from the website. Applications will continue to be available in the newsletters. Also under New Business, Mike Bishop reported that he had been working to get our CMSC membership dues working for the club but had not been successful in communicating with current CMSC leadership. However, just a few hours before this meeting, he did receive communication from the CMSC current Webmaster, Krista Petrolla, and hopes moving forward, help will be forthcoming in updating / linking our current trip news on their website.

**Vice President Report:** Gail Vogt was absent, President Mike Bishop reported the Executive Committee took a vote to decide if there should be a Get Psyched Party and a Quorum Vote of 3 yay, 1 nay and 1 N/A was reached. Because of the low membership response, catering will not be an option and Gail will continue to explore possibilities.

**Treasurer Report:** Melba Gasque reported the treasury hasn't changed much, with one membership credit. Melba also mentioned that she has received applications and vouchers towards SnowTrails passes.

**Secretary Report:** Jennifer Stephan reported she had nothing further to add.

**Merchandising:** Gail Vogt was absent, it was reported facemasks with the club logo will be made available to Benson workers first to promote the club. They are \$5 each and Gail is taking a wait list if you would like to be added.

Gary mentioned the annual Warren Miller Film would be held virtually on November 7, with availability to purchase and be eligible for contests. **Kayaking Report:** Jason Stephan reported on the "Once in a Blue Moon" glow paddle at Sippo Lake Park on October 31. Jason moved registration to 6:00 pm in anticipation of a good turnout after noting that a similar paddle brought six times the number of kayakers expected. Jason stated he advertised on the club Facebook page, his personal FB as well as Kayak NE Ohio. There will be a warming hut and Jason is looking for a few non-kayaking volunteers to help with registration, as well as put in and take out help.

## **2021 Breckenridge Trip On-line Registration Instructions:**

Speaking of a difference, the 2021 Breckenridge Ski trip will require on-line registration with the tour operator. The tour operator will oversee all terms and conditions of the trip. You will now be able to pay with a credit card with 3.3% fee, pay pal with a 2.75% fee, by check either mail in or phone in check nos. The trip has a base price which includes lodging, flights and bus transfers. You will be able to pick your Epic lift ticket either multi-day to the Epic pass (a few choices). Also, you will be able to pick, two types of insurance or decline insurance. Both these choice will affect the final price of you trip. Remember insurance is highly recommended but does not cover an epidemic but when it comes down to terms and conditions of trip, the tour operator will be in charge, not Stark County Ski Club.

This page will give a summary of what you have pick, plus insurance and information to fill out

Now your three choices on travel insurance (Highly recommended):

Decline insurance – read carefully tour operator terms and conditions apply, cancel is controlled by tour operator.

This will also tell you, your deposit and final balance and when balance is due.

After confirmation, all payments except vouchers will be directed to Ski.com, not Stark County Ski Club.

People with vouchers, please send to trip leader and the club will send the amount total of your vouchers that will be sent to the tour operator for credit on the trip. Remember if trip is cancelled and you paid with Vouchers, your refund will be in vouchers.

## **OHSAA says higher-seeded football teams will have the choice to host the regional finals**

COLUMBUS, Ohio — The Ohio High School Athletic Association said Tuesday afternoon the higher-seeded football teams will have the choice to host the regional final games this month. The OHSAA told member schools in a memo that those football teams may choose to host at a site other than their home location.

Traditionally, the regional finals have been hosted by neutral sites and the OHSAA is in some ways still treating it as such during this shortened season during the COVID-19 pandemic.

"Tournament games should be treated as a neutral site game," the OHSAA said. ....

The OHSAA also added the state semifinal games will be played at neutral sites chosen by the state athletics governing body. OHSAA football administrator Beau Rugg will select those sites.

"The site will be selected based on the best site available," the OHSAA said. "Equal travel distance is not a consideration."

The OHSAA has not said where the state finals locations will be held in November.

The Division I state final is scheduled for Nov. 13. Divisions II-VII will be played in the range of Nov. 19-22.

This Friday night is the Division I regional semifinals. Divisions II-VII are in the regional quarterfinals this weekend.

Here is some related information:

- There will be a maximum of 1500 fans in the stadium.
- **Workers must wear masks.** There is an assumption that all guests will be wearing them, too. The club masks are in! You can get yours for \$5. Let Donna know if you are interested in purchasing.
- There will be limited people in the concession stand. The counters are very wide, so there will also be a distance from the customers.
- Being a cashier will be the primary thing we do. Lately, we have had 1 person helping to make hot dogs.
- We will be issuing a \$45 Trip Discount Voucher for volunteering for each event or shift if more than one game per day during OHSAA Finals.

Balance shall be due & payable in accordance with payment schedules established by SCSC & described in the trip description in "Tips & Tails", the club newsletter, or on the club website [www.starkcountyskiclub.org](http://www.starkcountyskiclub.org). Charges may be added for supplemental costs such as fuel surcharges, taxes, single supplement for room and airport departure changes to the price of the trip. All payment checks shall be payable to "Stark County Ski Club" & sent to trip leader noted.

### **2. WITHDRAWAL & CHANGE:**

Stark County Ski Club (SCSC) may withdraw any trip from its schedule at any time; may refuse to accept or refrain any person as a participant at any time for any reason; and may change the itinerary at any time.

### **3. RESPONSIBILITY:**

Stark County Ski Club & TimkenSteel are acting gratuitously for the applicant and shall not be responsible or liable for any loss of or damage to any baggage, property, or for any loss, injury, illness, death, accident, delay, inconvenience or any other loss occurring during or occasioned by an applicant's participation in any trip, and as a result of any actual or alleged negligence of SCSC or any SCSC member or officer or due to any circumstances beyond the control of SCSC or any SCSC member or officer.

### **4. IDENTIFICATION:**

Participants are responsible for any required identification for travel. This may include, but not limited to, an up to date and valid passport, visa, drivers license or proof of identification and citizenship.

### **5. MINORS:**

Any minor's participant's "Trip Application & Agreement" must be co-signed by his/her parent or legal guardian. The minor must be accompanied on the trip by a parent or legal guardian or their designee who shall be wholly and fully responsible for said minor's conduct and well being.
