Hey there skiers, riders, and paddlers.

Don't think that this Summer could have been hotter, dryer, or have gone any quicker than it did. We have just finished up our regular schedule of Friday Night Floats, and with our Benson schedule and my sons marching band schedule, I will be tied up most of the Friday nights going forward for the rest of the year. I really couldn't have asked for better paddling weather, we only dogged rain drops and thunderstorms once this season.
