Welcome to Fall fellow skiers and riders, just like that summer is over and fall begins. If your inbox, and Facebook feed is anything like mine, you may have noticed an increase in winter related ads and posts.

We held our first meeting at our new venue, The Massillon Eagles, and I can report it is a nice meeting place, large with plenty of seating, our own bar and good, value priced food. The great thing with a buffet style meal, the food is ready for everyone at the same time; not having to wait for your meal and having servers interrupt during the meeting is a good thing. It is extremely important you RSVP and mark the number of guests if you are RSVPing for more than one person and if you are planning on dining. We are charged for the number of meals that we have RSVP's and last meeting we did end up owing for more meals than were paid for. This is partly on us as we did not have a column to show if a party/person was dining. We do ask if you are planning to attend the meeting that you RSVP even if you are not dining so we know what amount of seating is needed and bar staffing. Meals for the meeting are \$8.50 per person and we only accept cash, please bring close to the correct amount.

The Old Farmers Almanac is prognosticating a cold and snowy winter (let's hope) so it's time to think about getting those skis and boards ready for the season. Buckeye Sports is offering specials on winter tune ups and have sent coupons out, they are also planning a Ski fest and Swap starting September 29th through October 8th. Boston Mills/Brandywine will be holding their open House from October 13th to October 15th (Friday-Sunday) and our clubs own Joyce Tolerton and the Ski Shack in Alliance will be having their open house on November 4. This is also a planned social with a wine tasting at a neighboring business followed by dinner at Don Panchos. Joyce has reported starting regular business hours and is taking in skis for tune ups.

Our club is offering a nice variety of trips this season with two weeklong destination trips, one to an east coast destination, and the other to a Western Resort with two travel options - see trips and flyers for all the information. Some of our day trips this season will be shared with other clubs from CMSC. For this to happen we had to offer a one day temporary or associate membership, this keeps us in a good light with the IRS as the money we make from our volunteer activities from Tom Benson Hall of Fame brings in a significant amount of money for the club. The trips stated as a shared trip have a limited number of seats available to each club. If three clubs are participating, each club is assigned 1/3 of the seats on the bus. If two clubs are participating, then the bus is split in half. If you wish to participate or go on a shared trip it is highly encouraged that you sign up early, and if our portion is sold out, get on the waiting list. If the other clubs do not sell all their assigned seats, we will be able to purchase/use their unsold seats. The good thing about this arrangement is that if we experience a loss on the trip, the loss is shared by all participating clubs, not just one club.

The "Executive Committee" hereinafter referred to as the "Ex. Comm." is a permanent and standing sub-committee of the Board. The Ex. Voting by e-mail is permitted, previous president.

This proposed change would remove **past president** from the executive committee and replace with the **trip committee chair.**

October is here and we're starting to feel a chill in the air. Get your skis and boards tuned up because ski season is just around the corner. Sign up now for a fun slate of day, overnight, and week-long trips that your Trip Committee has worked hard to put together.

We've added an option on the Trip Application form for an *Associate Membership*. This is a one-time option for non-members to join our club for one-day trips. It is not for Stark County Ski Club members. We've mentioned before how we are working with other clubs to have their members join us on day trips to help cover motor coach cost. This option is for their use.

We need a minimum of 40 participants on bus trips in order to break even on the cost of the motor coach. Bus trips to Kissing Bridge and Blue Knob may be in jeopardy if we don't get a substantial increase in participation.

Jim Kovach, Trip Leader, has put together a treatise on the Ogden trip, which is included in this newsletter. This is a very challenging trip to manage, to say the least. There are two travel options: air or rail. There are two resorts: Snowbasin and Powder Mountain. There are group ticket restrictions that affect when we can ski or ride at each resort. There are several other challenges, as well. Kudos to Jim for working through all of these details to pull this trip together!

Welcome aboard!

We have progressed one month closer to departure. We are still in limbo on some of our trip details and costs. We will have to wait until approximately Oct. 15 for group lift ticket pricing from Snowbasin. Powder Mountain's prices DOUBLED from 2023 (we used 2023's to get our rough pricing). We are still awaiting Amtrak's rate for train travelers. We need to have 16 people to get a group rate. The Senior rate for those over 65 is about the same as the group rate as I am being told by Amtrak reps. Adult pricing would be about \$200 higher than senior rate. We have 10 signed up for the train (with 2 possibles) at this time. We have 13 signed up to fly.

Some of you have expressed interest in skiing all of your days at Powder Mountain. Unfortunately, 4 days at PM is NOT possible. Saturdays are Black Out days for groups. No group tickets are valid on Saturdays, and Sundays rate is \$30 more than our group rate. You would have to pay more to ski Sunday at PM. Most of those requesting 4 days at PM are over 75 years of age. That's a Super Senior in PM speak. Super Seniors ski for free at PM, but they have to spend \$6 to get a RFID card to access the lifts at Powder Mountain. The trip is set up for 3 days skiing at SB and 2 at PM for plane travelers and 2 days each at both resorts for train travelers. The train travelers will have to do their first 2 days, Thursday and Friday, at PM and Saturday and Sunday at Snowbasin. Plane travelers can mix and match except for PM on Saturday and Sunday.

The things we are completely certain of pricewise for this trip at this juncture are lodging and airfare. Our lodging includes transportation from airport or train depot to the Marriott Hotel. Bus transportation to both Powder Mountain and Snowbasin is provided and is available close to our front door. Breakfast is provided daily at the hotel. And, we will have a great time!

I will be updating you as information comes in. I will have a list of dining options and bar/cocktail opportunities near our hotel in the near future. If anyone wants to rent performance equipment while there instead of dragging your skis/poles along, let me know. I will research best options for that. This is a very complicated trip with many options built in. I will try to accommodate special requests within the limits of our signed contracts with air, train, hotel and ski areas.
